- (iii) not responsible or liable for disruption of travel arrangements, or any consequent additional expenses that may be incurred therefrom, and
- (iv) not responsible or liable for any loss, damage, or theft of my luggage or other personal belongings.
- SESPONSIBILITY FOR MEDICAL NEEDS: I represent to the University that I am aware of my personal medical needs and that there are no health-related reasons or problems that preclude or restrict my safe participation in the Trip. I understand and agree that the University assumes no liability or responsibility for any injury or damage that might arise out of or in connection with such authorized emergency medical treatment.

- 9. <u>INDEMNIFICATION</u>: I agree to indemnify, defend and hold the University and its trustees, officers, agents, and employees ("collectively the indemnities") harmless from any liability, claim, action, damage, loss, fine, penalty, cost or expense (including, without limitation, reasonable attorneys' fees) of every kind or nature, asserted by any individual or entity against any of the indemnities or incurred by any of the indemnities and arising directly or indirectly from or in connection with my participation in the Trip or any of the activities I engage in during the Trip, except to the extent that any liability, claim, action, damage, loss, fine, penalty, cost or expense arises out of, results from or is connected with the negligence or willful misconduct or intentional misconduct of the University or its employees or students (excluding me), agents or contractors.
- 10. **RESERVATION OF RIGHTS**: I acknowledge that the University reserves the following rights that it may exercise in its sole discretion: (i) the right to cancel the Trip, and (ii) the right to make

	alterations, changes, and modifications in any part of the Trip itinerary and the activities in connection therewith.
